Underground Mine Foreman Prerequisites:

- a) At least four years of varied underground coal mining experience.
 - b) Copy of Utah Fire Boss Certification
 - c) Copy of Mine Rescue training or annual refresher training received within one year of application deadline.
 - d) Statement from employer(s) verifying four years of varied underground coal mining experience and jobs performed.
- * Out of state certified applicants now working in Utah coal industry and applying to take the Utah Mine Foreman Certification Examination shall provide a copy of their Mine Foreman, Assistant Mine Foreman, or Fire Boss certificates from other states.

Surface Mine Foreman Prerequisites:

- a) At least three years of varied surface coal mining, or equivalent experience.
 - b) Statement from employer(s) verifying three years of varied surface coal mining, or equivalent experience and jobs performed.
- * Out of state certified applicants now working in Utah coal industry and applying to take the Utah Surface Mine Foreman Certification Examination shall provide a copy of their Surface Mine Foreman or Assistant Surface Mine Foreman certificates from other states.

Fire Boss Prerequisites:

- a) At least two years of varied underground coal mining experience.
 - b) Statement from employer(s) verifying two years of varied underground coal mining experience and jobs performed.
- * Out of state certified applicants now working in Utah coal industry and applying to take the Utah Fire Boss Certification Examination shall provide a copy of their Fire Boss certificates from other states.

Underground Electrician Prerequisites:

- a) At least one year of varied electrical experience, as specified in 30 C.F.R. Section 75.153.
 - b) Copy of Methane Detection Card, or Utah Fire Boss or Underground Mine Foreman certification.
 - c) Statement from employer(s) verifying one year of varied electrical experience and jobs performed.
- * Out of state certified applicants now working in Utah coal industry and applying to take the Utah Underground Electrician Certification Examination shall provide a copy of their Underground Electrician certificate from the Mine Safety and Health Administration (MSHA) or other state.

Surface Electrician Prerequisites:

- a) At least one year of varied surface electrical experience as specified in 30 C.F.R. Section 77.103.
 - b) Statement from employer(s) verifying one year of varied surface electrical experience and jobs performed.
- * Out of state certified applicants now working in Utah coal industry and applying to take the Utah Surface Electrician Certification Examination shall provide a copy of their Surface Electrician certificate from the Mine Safety and Health Administration (MSHA) or other state.
