- 1. Kent Houghton, Chairman – Meeting called to order 9:358 A.M.**
 - Approval of the last meeting minutes.

- 2. Report to MSTAC-** Kent Houghton addressed the meeting and gave a summary of the activities of the Office of Coal Mine Safety for the quarter. He visited every coal mine in the state during the quarter and met with their respective safety departments. He gave overview of the mining industry and coal mine safety in the state and discussed the new regulations for proximity detectors on the Continuous Miners which goes into effect this year. He attended the LEPC meetings for Sevier and Emery Counties. He also attended the Rocky Mountain Mine Rescue Meetings.

3. **Old Business** – Update on H.B.-149 designating the University of Utah Center for Mine Safety and Health Excellence to be the Utah Research Institute for Mine Safety and Productivity. This was a recommendation to the Legislature and Governor by the MSTAC in the September 15, 2014 meeting from a proposal by Thomas Hethmon. The bill has passed the house and senate and goes to the Governor for signing.
4. **New Business** – There is still a vacancy on the MSTAC for a coal mining experience representative. It was suggested that the companies that have no one on the council be contacted again to see if they have any one interested. Kent Houghton will follow up on this suggestion.
