Re: Proof of Coverage Reporting Requirements and Penalties

As announced 8/24/12, the Industrial Accidents Division intended to transition from the IAIABC POC 2.1 to the POC 3.0 standard on 9/1/13. Per our 7/16/13 notice, this implementation date was postponed to November 6, 2013.

Although carriers will continue to report workers' compensation policy information to their data collectors using the WCPOLS format, they should ensure comprehension of the Utah data reporting requirements by reviewing the POC 3.0 tables posted on our website: http://laborcommission.utah.gov/divisions/IndustrialAccidents/policy_reporting.html

In Bulletin 8-2010 the Industrial Accidents Division outlined the procedures used for assessing the penalties resulting from noncompliance with §34A-2-205. In Bulletin 5-2011 the Industrial Accidents Division provided a list of fineable transactions. As there are some new transactions in POC 3.0 that will be fineable, following is an updated list of all fineable transactions effective 11/6/13. Those highlighted in green are new report types available in POC 3.0.
